

JC Cowboys Jingle Dance Contest Rules

Sponsor: JC Cowboys, LLC

How to Enter: Visit www.jccowboys.com to listen to and download JC Cowboys' jingle. All video entries for the contest must be uploaded to Facebook and/or Instagram using the hashtag "#JCCowboysJingle". An entrant may upload an unlimited number of unique, individual videos for the contest. Each entry must be in video form. Any uploaded video that contains vulgarity or that modifies the JC Cowboys jingle in any way shall be immediately disqualified from the contest. The contest begins December 14, 2021, and ends January 31, 2022.

Nature of Contest: Recorded video of a dance to JC Cowboys' jingle. The best dance, as selected by JC Cowboys' staff, will be the winner.

Prize: The contest winner may choose between one (1) of the following prizes:

- One (1) evening (5 pm to 12 am) of free food and drinks for the contest winner and a companion selected by the contest winner (party of two (2)) at JC Cowboys and a one (1) night hotel stay in Weatherford (hotel stay must be on same night as the evening of food/drinks at JC Cowboys and accommodation to be selected by JC Cowboys, in its sole discretion); OR
- \$500.00 in the form of cash or a prepaid credit card (to be selected by JC Cowboys, in its sole discretion).

The estimate retail value of the prize is \$500.00.

Contest winner: The contest winner will be selected by the JC Cowboys' staff. A winner will be selected on or about February 4, 2022. The contest winner will be notified by social media, phone, or email, and must claim the prize within seven (7) days of notification.

Conditions: All expenses incurred that are not specifically listed as part of the prize are not included and shall be responsibility of the contest winner, including but not limited to ground transportation, in-room charges, souvenirs, travel, and any form of insurance. All federal, state, and local taxes shall be the sole responsibility of the contest winner. The contest winner may be required to provide a major credit card upon check-in at the accommodations, where any in-room charges will be charged to such card. Any damage to the accommodations attributed to the contest winner and/or his or her companion will be the responsibility of the contest winner. No purchase necessary.
